The Meadows Public Inquiry — There is still no news concerning a future date for the Inquiry. The Clerk will continue to press Helen Whately's MP office for updates on the progress that she is making with government ministers. An early reply is not expected given the events unfolding over Brexit.

1 High Street, Headcorn — Breach in planning conditions by installation of external ducting without the appropriate permissions. It was reported that the parish council had received an email from the Planning Officer stating that a retrospective planning application had been submitted and he would update the parish council accordingly. No application has yet been received and the Clerk will chase up the matter.

Replacement of MBC waste bin on High Street - The Clerk continues to press for the replacement to be sited.

Land north of Lenham Road (Hop Pocket Way) – No further action will be taken by MBC in this regard as the planning conditions have been signed off and the matter is being dealt with by Southern Water. The Clerk will be attending Headcorn Flood Forum meetings and will pursue the matter in that forum.

PROW Grigg Lane to Lenham Road This matter is in hand with the Clerk and Open Spaces Committee and would be pursued in that forum.
