APP/U2235/W/18/3198435 Ten Acre Farm Love Lane Headcorn – There was nothing further to report on this appeal at this time. 1 High Street, Headcorn – Breach in planning conditions by installation of external ducting without the appropriate permissions. The Clerk advised that an email had been received from MBC (25<sup>th</sup> Feb) advising that due to absences in the planning enforcement team the matter had not yet been chased but would be chased when the officer returns to the office. In the interim it was noted that only cases of highest priority have been addressed. Clerk will follow up.

Martins Gardens, Lenham Road, Headcorn – It was noted that the committee's representations, after consideration of the planning applications at the last meeting, had been submitted to the LPA.

Signs at Headcorn Bowls Club remain very low over the footpath and have not been attended to despite being reported to Highways the Clerk will therefore follow up with Kent Highways.

Green Wicket Animal Sanctuary – Use of general waste bins in Headcorn for disposal of animal waste - the Clerk advised that there had been a brief response from Ashford Borough Council which stated that their investigations had been concluded and no further action would be taken. The Clerk had chased MBC for a replacement bin and it should be with us shortly.

Ash Gardens Lenham Road Headcorn – nothing to report since the appeal hearing on January 16<sup>th</sup> 2019.

Day Rooms on G&T sites – the Clerk had pursued the matter of guidelines being issued to planning officers following a decision at the SPS&T on January 8<sup>th</sup>. An email had been received from Mr. Rob Jarman (8<sup>th</sup> Feb) that states

No written guidance has been issued. However I have highlighted to officers the reference to impact on character and appearance set out in Strategic Policy 17. I am satisfied that they continue to apply their professional judgement in this key respect.

The matter was discussed by committee and it was agreed going forward that we will insist on scale drawings and that includes the scale of the day rooms.

The Clerk advised the committee on the following matters:-

- 1. Despite previous indications it seems that the occupier of the business known as Veg in the Shed on the High Street would not be submitting an application in relation to the Cushty Crab venture. It seems that the entire site has been vacated.
- 2. Land North of Lenham Road (Hop Pocket Way) The Clerk is seeking clarification from the LPA as to why a planning conditions about foul and surface water sewerage disposal was discharged when the matter had not been fully resolved. Rather the matter has been delegated to the developer and Southern Water, the question then is if the matter is not one of planning consideration (as per the decision notice) why would it form part of the conditions in the first place. Response awaited from LPA.
